GOVERNANCE EXPERIENCE

I serve on the board for the Taylor Bridge Replacement Project, along with executives in the Ministry of Transportation and Infrastructure (MOTI) and the Ministry of Health. Taylor Bridge connects Hwy 97 between Dawson Creek and Ft. St. John across the Peace River in northeastern BC. The bridge, a non-redundant structure critical to the safety and economic development of the region, is aging and in need of repair or replacement. The project is in the planning stages.

I also serve on the program board for the Cariboo Roads Recovery Program, along with executives from MOTI, Emergency Management BC and the Ministry of Education. The program was established to respond to the damage of major roads between Williams Lake and Quesnel on or adjacent to Hwy 97 due to landslides from heavy rains in 2020-2021.

I am an Assistant VP with Infrastructure BC (IBC), a provincial Crown Corporation owned by the Ministry of Finance. IBC provides planning and procurement services to capital ministries and other government agencies in relation to complex infrastructure projects. The projects I am responsible for, within the scope of IBC's engagement, generally have a capital value of between \$1B and \$4B; therefore, there is a high level of due diligence in all activities, including financial analysis, risk management and strategic procurement.

I have a strong background in financial analysis, risk management, contracts, governance, and stakeholder relations. I am also a CPA in good standing with the Chartered Professional Accountants of BC.
